- All assessments must be concluded by the 31st of October 2023
- Shortlisted candidates will be contacted via email for a scheduled virtual Pitch Panel session with selected experts within the industry to pitch their proposals.
- Applicants will be advised to share their pitch stories on social media to garner points.
- A virtual pitch assessment will be conducted daily for 20 shortlisted applicants for the next 5 days.

#### Upon conclusion,

- The 10 exceptional business projects will be given a grant award of N1,000,000 each and a provisional offer of loan approval.
- The next top 40 best business proposals will be given a provisional offer of loan approval.
